



## STUDENT DRIVING/PARKING AGREEMENT

I, \_\_\_\_\_ (student) understand that a parking permit is a **privilege** that may be revoked without a refund. The following must be adhered to along with any other school policy or rules that are deemed necessary for the safety and protection of school property, students, and personnel.

Student:

1. Will have their parking tag hanging and **clearly visible** on the front mirror of the car being driven.
2. Will follow all traffic rules and display prudent safe driving practices at all times.
3. Will follow all posted rules regarding **speed limits, traffic direction, and parking assignments.**
4. Will not be part of any illegal activities on the parking lots or misuse of the parking permit.
5. Will not pass a bus which has its stop arm displayed.
6. Will follow all other regulations concerning driving/parking listed in the handbook.
7. Will respect all other vehicles on the parking lot.
8. Will maintain good student conduct and academic performance.
9. Will agree to mandatory drug tests.
10. Will not walk across the athletic fields, track, and football field. (ACHS only)
11. Will park at their assigned area or be towed, **without a warning**, at the owners' expense.

**NOTE: Vehicles without a parking permit and those that do not follow driving/parking rules will be towed at the owner's expense.**

I understand that any infraction of the above rules or any other rule listed in the student handbook related to my driving or parking may lead to my parking permit being **revoked without a refund**. If I violate any of the driving/parking regulations, my permit may be **automatically revoked without a refund**. I also understand that my driving/parking privileges may be **revoked without a refund** due to first period tardies/absences. I understand that my permit must be displayed properly for me to park in the designated student parking lot. School authorities may search a student's vehicle when there are reasonable grounds for suspecting that the search may produce evidence that the student has violated or is violating either the law or the rules of District 117. **District 117 is not responsible for the security of vehicles parked on school property.**

I have read, understand, and agree to follow all rules and procedures in regard to student driving/parking listed in this agreement and the student handbook.
